Superintendent's Letter to the Community

To ensure that only students who reside within District 127 school boundaries attend District 127 schools, the Board and administration are requiring **ALL parents to show the following proof of residency for the 2005-06 school year:**

- Two separate (originals) and current (June, July '05) utility bills (e.g., gas, electric, water, cable)
- Current Phone Bill (July '05)
- Cell Phone Bill (July '05)
- Address Correction from the Post Office
- Bank Statements of the resident
- Payroll Letter stating the address of the resident

You will need to provide three of the six items listed above to prove residency.

Please note that according to the Illinois School Code, "A person who knowingly or willfully presents to any school district any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in that district without the payment of a non-resident tuition charge shall be guilty of a Class C Misdemeanor" (105 ILCS 5/10-20.126bf). Therefore, parents of non-resident students will be charged out of district tuition for the days the student has been attending classes in District 127. A tuition charge will be billed if you are found to live out-of-district.

Residency must be verified by August 19th, or your child's start date may be affected.

Finally, the District needs verification of custody for students whose custody has changed since the previous school year. If this applies to your student, please bring a

copy of the custodial papers with you to the school when verifying residency.
