ACTION ITEMS:

1. Minutes, financial matters, and bills payable were approved.
2. Personnel - all items were approved as follows:

3. The board authorized the payment of June bills for FY06, with a report of these bills to be included in the July board packet.
4. The board approved the FY07 Parent/Student Handbook, with the addition of language regarding in-school and out-of-school suspensions.
5. The board approved the FY07 Employee Procedures Handbook.
6. The board authorized the transfer of \$97,260.73 from the Activity Fund to the Education Fund and \$1,630 from the Activity Fund to the Operations and Maintenance Fund.
7. The board approved the resolutions to transfer interest from the Bond and Interest and Working Cash Funds to the IMRF Fund.
8. The board approved resolutions abating the Working Cash Fund as follows:
 - \$300,000 to the IMRF Fund
 - \$200,000 to the Operations and Maintenance Fund
 - \$100,000 to the Transportation Fund
9. The board approved the prevailing wage resolution.
10. The board approved the District/Cooperative Annual Review of Safety Plans, Protocols, Procedures, and School Safety Drills Report.

11. The board approved two contracts with the Alternative Academic Achievement Academy.
